CORRIGENDUM-III

Refer Tender Enquiry No. TPNODL/OT/2021-22/086 Dtd. 08.10.2021 for “RATE CONTRACT FOR SUPPLY OF LT AB CABLE (4x70+1x50+1x16 sq.mm) & COVERED CONDUCTOR (232 & 100 sq.mm) AAAC”

1. The revised qualification criteria shall be as mentioned below.

a) **Group-A** The bidder should have its own production facility to manufacture the materials of same or higher grade level for which he submits his offer with furnishing the poof of documents. Bidder must submit undertaking in this regard.

For Group-B

Authorized distributor can also participate if the covered conductor is being imported from abroad. However, Bidder's undertaking and an authorization letter from OEM providing acceptance to the below mentioned points will be required, else the bids shall not be considered during technical evaluation.

i) To ensure quality of material from abroad manufacturers, online vendor evaluation of OEM shall be done.

ii) Further for material acceptance, witness testing (in presence of TPNODL's representative) from in-house bidder's lab (authorized distributor's lab) / third party NABL lab is mandatory

b) The bidder should have supplied the AB Cable of 500km quantity of similar or higher rating during immediate last 3 financial years for Group-A and Covered conductor AAAC of 200 Km quantity of similar or higher rating during immediate last 5 financial years for Group-B. Copy of work order / completion certificate to be submitted in this regard.

c) The bidder should have performance certificates from at least 2 reputed companies for similar or higher voltage rating of similar supply. The supply against these issued certificates should be completed in last five years from the date of bid submission. In case the bidder has a previous association with TPNODL for similar products and services, the performance feedback for that bidder by TPNODL's User Group shall only be considered irrespective of performance certificates issued by any third organization. Copy of performance certificates to be submitted in this regard.

d) The offered materials should have been Type Tested at certified test laboratories which are CPRI/ ERDA or equivalent only. The type test report should have same rating or higher rating of similar category of quoted materials. The bid shall be accompanied with such Test Reports which should be conducted within five years before the date of opening of the tender. Test report shall be submitted in this regard. In case, bidder do not have the type test report, they shall submit the undertaking that same shall be provided (if required by TPNODL) in case they would appear as successful bidder.

e) The bidder should have average annual turnover of Rs. 12 Crore for Group-A and Rs. 8 Crore for Group-B or above for last consecutive Three Finance Year. If the bidder shall be quoted for multiple group, the turnover will be calculated cumulatively. Bidders have to submit copy of audited Balance Sheet and P&L Account in this regard.

f) The bidder should have in-house facilities for acceptance tests as per TPNODL specifications. Self-undertaking to be submitted in this regard. TPNODL reserves the right to inspect the said manufacturing facility as a proof of compliance to this parameter. Bidder must submit undertaking in this regard. **(Only for Group-A, not applicable for Group-B)**

*g) The bidder should have valid ISI certification for all the sizes of the cables. **(Only for Group-A, not applicable for Group-B)***

- 2. The due date and time for bid submission shall be 03.11.2021, 15:00 Hours.**
- 3. Date & Time of opening technical bids & EMD shall be 03.11.2021, 15:30 Hours.**
- 4. All other terms & conditions will remain same as mentioned in the tender document.**
